### **TOP 5 UNMET NEEDS ACROSS ALL 3 REGIONS:**

**1. Substance Use Treatment** (assisted withdrawl, outpatient and residential treatment)

2. Sexual Behavior Treatment

**3.** Greater Access to In-home Services including FFT, MST, MST-BSP

**4. Short-term Housing** (attendant care, respite, detention alternatives)

**5. Home-based Services in Rural Areas** (Oxford, Franklin, Kennebec, Lincoln Counties)
